DURING THE SCHOOL YEAR, LET'S READ VOLUNTEERS SHARE STORIES AND RHYMES, DISTRIBUTE LIBRARY CARDS, ENCOURAGE LIBRARY USE, AND SUPPORT READING AT HOME. EACH WEEK, APPROXIMATELY 1,000 CHILDREN ARE REACHED BY THE LET'S READ PROGRAM. THE LIBRARY HAS GIVEN 33,000 GIFT BOOKS TO LET'S READ STUDENTS, BUILDING THE HOME LIBRARIES OF VULNERABLE YOUTH.

SUMMER LEARNING AND READING IS A TWO-MONTH PROGRAM IN JUNE AND JULY PROVIDING A SAFE, EASILY ACCESSIBLE LEARNING ENVIRONMENT TO ENABLE CHILDREN TO MAINTAIN AND BUILD THEIR SKILLS IN READING, WRITING, SCIENCE, AND MATH. STUDENTS ARE INSTRUCTED BY STATE-CERTIFIED TEACHERS AND SUBJECTS COVERED ARE TAILORED TO EACH GRADE LEVEL. THIS PROGRAM BUILDS EXCITEMENT ABOUT LITERACY AND READING BY PREPARING CHILDREN TO START THE NEW SCHOOL YEAR WELL-FED, HEALTHY, MENTALLY ACTIVE, AND READY TO LEARN. THE PROGRAM ALSO PROVIDES GIFT BOOKS FOR UPWARDS OF 3,000 CHILDREN TO FOSTER A LOVE OF READING AND HELP BUILD HOME LIBRARIES.

STUDIO 411 WAS LAUNCHED IN 2018 AS A COMPREHENSIVE SPACE FOR CREATIVES TO EXPERIENCE A RANGE OF ARTS PROGRAMS ON OUR SECOND FLOOR. STUDIO 411 ENHANCES THE LIBRARY'S PROGRAMMING BY ALLOWING ARTISTS TO SHARE THEIR TECHNIQUES AND BY STRENGTHENING THE CONNECTION BETWEEN THE ARTS COMMUNITY AND OUR PATRONS. PROGRAMMING IN STUDIO 411 INCLUDES HANDS-ON ART CLASSES IN VARIOUS MEDIUMS, ART LECTURES, STUDIO TIME FOR ARTISTS TO WORK INDEPENDENTLY AND CREATIVE TRAINING FOR CREATIVE ENTREPRENEURS, AMONG OTHERS.

THE TECHNOLOGY AND INNOVATION CENTER, OPENED IN 2022, WAS CREATED TO EMPOWER TEEN AND ADULT PATRONS WITH CREATIVITY AND COLLABORATION THROUGH STATE-OF-THE-ART EQUIPMENT. A SPECIALIZED STAFF MEMBER PROVIDES ASSISTANCE AND TRAINING WITH MEDIA PRODUCTION IN: VIRTUAL REALITY, MEDIA DIGITIZATION, DRAWING AND ANIMATION, MUSIC AND PODCASTING, AND 3D DESIGN & PRINTING. THESE SERVICES AND THE SPECIALIZED EQUIPMENT AVAILABLE EMPOWERS CREATIVITY FOR PATRONS IN AREAS SUCH AS JOB TRAINING, EMPLOYMENT COACHING OR PREPARATION, ENTREPRENEURSHIP, BOOSTING STUDENTS AND JOB SEEKERS WITH THE TEACHING OF TECHNOLOGY SKILLS, AND LEARNING HIGH-TECH SKILLS TO IMPROVE THEIR LIFE OPPORTUNITIES.

WELLNESS CLASSES ARE AN INTEGRAL PART OF PROVIDING A SENSE OF COMMUNITY TO OUR PATRONS, WITH OPPORTUNITIES FOR EVERY AGE WHICH RANGE FROM TAKING FOREIGN LANGUAGE CLASSES OR CREATIVE WRITING WORKSHOPS, TO YOGA CLASSES FOR
